Accordingly we do not express an audit opinion.

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

#### Inherent Limitations

It was impracticable for us to quantify the potential impact of this on the income and expenditure account. Accordingly, our report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.

## AUTISM PARTNERSHIP FOUNDATION LIMITED NOTES TO THE INCOME AND EXPENDITURE ACCOUNT "SMART BABY CHARITABLE CRAWLING COMPETITION 2018" HELD ON 1 MAY 2018

#### Basis of preparation

- 1. Autism Partnership Foundation limited was incorporated in Hong Kong. The principal activities of the Permittee are providing intensive therapy to children with Autism Spectrum Disorder from low-income families as well as organising trainings and workshops for parents in handling and improving the behavioral problems of their children.
- 2. The Permittee is situated at Unit 1103, 11/F., Sun Cheong Industrial Building, 1 Cheung Shun Street, Lai Chi Kok, Kowloon.
- 3. The Event operated under Public Subscription Permit No. 2018/120/1 issued by the Social Welfare Departure is an integral part of the Permittee's operation, and is an Event held by the Permittee in the year 2018 for the purpose of raising permittee's funds by the method of Donation boxes collection for providing treatment and related services to underprivileged children with Autism and their families.
- 4. This income and expenditure account is prepared on historical cost convention and accounted on an accrual basis.
- 5. The significant accounting policies are set out below:
  - i) All monies received from public subscription of the Event are recognised as donation receipt according to donations collected.
  - ii) Expenditures are those incurred directly in relation to the Event and for the period covered accordingly.
